TERMS OF USE

1. Acceptance of Terms

1. Please check these Terms of Use periodically for changes. If you do not agree to the Terms of Use, please do not use the Site. Your continued use of this Site following the posting of any changes to the Terms of Use constitutes acceptance of those changes.

2. Credentials & Passwords
